AND WHEREAS the Trustees have now decided to amend the Trust Deed by altering the object close No. 1 and 5.


1. AMENDMENTS CLAUSE NO. 1

BEFORE AMENDMENTS

1. The Trust shall be called PKM EDUCATIONAL AND CHARITABLE TRUST MANJERI.

AFTER AMENDMENT

1. Dr. Siyad K.A informed the other Trustees that the Trust has discontinued its Operation in Manjeri. The Trust is running a School in its own building at Tana, Mampad, Nilambur by name "The Springs International Schools" Hence, it was unanimously resolved that the address of the Trust can be shifted to Mampad Grama Panchayath Building No. 10/324A, "Springs International Schools, Tana, Mampad (P.O), Nilambur Taluk, Malappuram District, Kerala Pin 676542" which will hereafter shall be the registered office address of the Trust.


2. AMENDMENT TO CLAUSE NO. 5 (Chairman of the Trust Board)

BEFORE AMENDMENT

Dr. Abdul Razak appointed himself as the Chairman and Managing Trustee of the Board for the rest of his life.


AFTER AMENDMENT

The Chairman of the Trust Dr. P. Abdul Razak passed away on 28-09-2015. In his place a new Chairman has to be appointed to carry out the activities of the Charitable Trust. After deliberation it was unanimously resolved that Sri. Dr. Siyad K.A shall be appointed as Chairman of the Trust. Other legal hires of Sr. P. Abdul Razak namely 1. Dr. Arifa Abdul





